



PASHIZ COINS LTD
ONLINE SHOP CONSIGNMENT AGREEMENT

This Agreement ("ONLINE SHOP CONSIGNMENT AGREEMENT") is entered into between Pashiz Coins Ltd, hereinafter referred to as the "Seller," and the individual or entity consigning items for auction, hereinafter referred to as the "Consignor."

1. Consignment Services

1.1 Online Shop Services: The Seller will facilitate the listing and sale of items in the Online venues.

1.2 Online Shop Fee: The Consignor agrees to pay a fixed fee of 15% of the sold price for each item, with a minimum fee of 12 GBP.

1.3 Payment Schedule: Payment to the Consignor will be made regularly every month on the 10th day of the next month. For example, items sold in October will be paid out on the 10th of November.

2. Payment Methods

2.1 Payment Methods: The Consignor can choose one of the following payment methods: bank transfer, cryptocurrency, PayPal, or Western Union. The Consignor is responsible for all payment fees associated with the chosen method.

3. Reporting and Accountability

3.1 Item Records: The Seller will provide the Consignor with monthly sales reports, detailing the sales of their consigned items, fees, and payments.

3.2 Inventory Tracking: The Seller will maintain accurate records of all consigned items, including descriptions, listing dates, selling prices, and remaining inventory.



4. Unsold Items

4.1 The Consignor may request the return of unsold items only 30 days after the consignment date, and the cost of return shipping will be borne by the Consignor.

5. Liability and Indemnification

5.1 Seller Responsibility: The Seller will take all reasonable precautions to ensure the safe handling of consigned items.

5.2 Item Description: The Consignor will provide a detailed description of each item being consigned, including but not limited to type, denomination, year, and condition.

3.4 Shipping and Insurance: The Consignor is responsible for shipping the items to the Seller, and the Consignor is encouraged to insure the items during transit.

6. Termination

This Agreement may be terminated by either party upon written notice. In the event of termination, the Consignor shall remain responsible for any fees incurred up to the date of termination.

6. Governing Law

This Agreement is governed by the laws of United Kingdom of Great Britain and Northern Ireland. Any disputes arising under or in connection with this Agreement shall be resolved through arbitration or mediation, as mutually agreed upon by both parties.

7. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes any prior or contemporaneous agreements, whether written or oral.
