



## **Coin and Banknote Submission Agreement**

This Agreement ("Agreement") is entered into between Pashiz Coins Ltd, hereinafter referred to as the "Service Provider," and the individual or entity submitting coins and banknotes for grading, hereinafter referred to as the "Submitter."

### **1. Services Provided**

The Service Provider offers the following services to the Submitter:

1.1 Grading Submission: The Service Provider will facilitate the submission of coins and banknotes to NGC (Numismatic Guaranty Corporation) and PMG (Paper Money Guaranty) for grading and encapsulation.

1.2 Service Fee: The Submitter agrees to pay a service fee equal to 1.25% of the fair market value of the submitted items, with a minimum of 40 GBP (VAT inclusive), in addition to the grading fees payable to NGC/PMG.

1.3. Service fee is due and payable by Submitter regardless of the grading decisions made by NGC/PMG or whether they accept or reject the items for grading.

### **2. Submission Process**

2.1 Item Description: The Submitter will provide a detailed description of each coin and banknote being submitted, including but not limited to type, denomination, year, and condition.

2.2 Fair Market Value: The fair market value of each item will be determined by the Service Provider, and this value will be used to calculate the service fee.

2.3 Payment: The Submitter agrees to pay the service fee in advance, and the grading fees to NGC/PMG will be paid separately as per the NGC/PMG fee schedule.

2.4 Shipping and Insurance: The Submitter is responsible for shipping the items to the Service Provider, and the Submitter is encouraged to insure the items during transit.



2.5 Submission to NGC/PMG: The Service Provider will submit the items to NGC/PMG on behalf of the Submitter and will keep the Submitter informed of the grading process.

### **3. Grading Results**

3.1 NGC/PMG Decision: The grading and encapsulation decisions made by NGC/PMG are final. The Submitter acknowledges that the Service Provider has no influence over these decisions.

3.2 Notification: The Submitter will be promptly notified of the results of the grading process, including the assigned grades and encapsulation details.

### **4. Liability and Indemnification**

4.1 Service Provider's Responsibility: The Service Provider will take all reasonable precautions to ensure the safe handling of submitted items. However, the Service Provider is not responsible for any loss, theft, damage, or any other issues related to the grading process.

4.2 Indemnification: The Submitter agrees to indemnify and hold harmless the Service Provider from any claims, losses, or liabilities arising from the submission process.

### **5. Termination**

This Agreement may be terminated by either party upon written notice. In the event of termination, the Submitter shall remain responsible for any fees incurred up to the date of termination.

### **6. Governing Law**

This Agreement is governed by the laws of United Kingdom of Great Britain and Northern Ireland. Any disputes arising under or in connection with this Agreement shall be resolved through arbitration or mediation, as mutually agreed upon by both parties.

### **7. Entire Agreement**

This Agreement constitutes the entire understanding between the parties and supersedes any prior or contemporaneous agreements, whether written or oral.
